# MINUTES

A motion was made by Mr. Miklos and seconded by Ms. Morris to approve the August 25, 2020 Council Meeting Minutes. Upon a roll call vote Mr. Miklos, Ms. Morris and President Rager were in favor. Mr. Shaner abstained due to being absent from the August 25, 2020 meeting.

#### PAYMENT OF BILLS

A motion was made by Mr. Miklos and seconded by Mr. Shaner to pay the bill list dated September 19, 2020 in the amount of \$116,996.52 and withholding the airduct cleaning bill until the work is completed. Upon a roll call vote all were in favor, motion carries.

#### TREASURER'S REPORT

A motion was made by Mr. Miklos and seconded by Ms Morris to approve the August 2020 Treasurer's Report with the amendment of adding the information of the 2016 PNC Ford Explorer Car Loan Information. Upon a roll call vote all were in favor, motion carries.

A motion was made by Mr. Miklos and seconded by Mr. Shaner to advertise for a Part-time Public Works Laborer. Upon a roll call vote all were in favor, motion carries.

A motion was made by Mr. Miklos and seconded by Ms. Morris to prepare the 2014 Ford Explorer to be sold on Municibid and relocate it back to the municipal building. Upon a roll call vote all were in favor, motion carries.

A motion was made by Mr. Miklos and seconded by Mr. Shaner to authorize the Light Up Might Special Event Application submitted by the EADC for Thursday, November 19, 2020. Activities for the event are to include lighting of the Christmas tree and Santa Claus will be present. The event will take place in the area of Plum Street and Market and Strawberry from 6 p.m. to 8:30 p.m. Upon a roll call vote all were in favor, motion carries.
